The purpose of this Privacy Policy ("Privacy Policy") is to ensure that the users / visitors of the Site ("Data") are provided through this website ("Site") operated by One World Danışmanlık Eğitim ve Araştırma Hizmetleri Limited Şirketi ("One World or the Company"), identifying the terms and conditions regarding the use of personal data ("Personal Data") shared with the Company or the Company's Data Owner generates during the use of the Site and how the Personal Data is processed by One World, it is to explain to them before entering various sections and giving their Personal Data.

# **Which Personal Data Are Processed?**

The contact addresses or telephone, e-mail address specified on the Site, including but not limited to the name, address, e-mail address, telephone number, date of birth, age, gender, job-related information (CVs, etc.) of the Data Owners. or through other channels, publicly available information will be collected and processed.

The following information is collected automatically when Data Owners enter the Site.

- Technical information such as the Internet protocol (IP) address used by the user's computer while connecting to the Internet, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;
- Full Uniform Resource Locator (URL), click behavior (including date and time) on login, site navigation and exit from the Site, page response times, download errors, visit times of certain pages, page interaction information (such as page scrolling, clicking and navigation), information about Data Owners' visits, including methods used to leave the page

#### The Nature of the Personal Data Processed

For our Company to respond to user needs regarding Site functions, it is mandatory to provide the personal data requested in the boxes marked with an asterisk. Failure to provide compulsory personal data required for the requested services - or provide incomplete or incorrect information - will make it impossible to carry out these activities. On the other hand, if none or some of the optional personal data is not provided or if incorrect information is provided, there will be no disruption to the services.

#### **Who Can Access Your Personal Data?**

Providing and managing various services provided by our Company and fulfilling the demands of customers / candidates regarding these services, within the scope of the personal data processing conditions and purposes specified in Articles 5 and 6 of the Personal Data Protection Law No.6698 ("Law") Carrying out the necessary work by our relevant business units for the realization of the activities carried out by the Company and conducting the related business processes, ensuring the legal and commercial security of our Company and the persons who are in business relations with our Company, carrying out the necessary works by our business units to benefit those concerned from the services offered by our Company. Receiving feedback for services, answering questions ("Communication" section of the Site) and conducting related researches, developing our services in line with your requests and needs, For the purposes of determining and implementing the Site, managing the Site and eliminating the malfunctions, performing internal processes for data analysis, tests, research, statistics and auditing, updating information about the Site, and obtaining information about the information you share with us for the continuation of our business activities. Business partners, shareholders, customers and consultants, legally authorized institutions and organizations, legally authorized private law legal entities, third parties such as outsourcing service providers, hosting service providers (hosting services), law offices, accounting and by our Company as Data Processor can be shared with third parties at home and abroad.

#### **Storage Period of Personal Data**

The Company will keep the personal data provided by the Data Owner for the duration of the services provided in order to fulfill the obligations arising from the nature of the services it provides.

In addition, in the event of any conflict that may arise between the Data Owner and the Company, the Company will be able to store personal data for the period of limitation specified in accordance with the relevant legislation, limited to the purpose of making the necessary defenses.

# **Personal Data and Children**

In case of linking to other applications through the site, the Company does not bear any responsibility for the privacy policies and contents of the applications.

# Rights of Data Owners and Exercising of These Rights

The rights you have in accordance with Article 11 of the Law are as follows:

- Learning whether personal data is processed,
- Requesting information if personal data has been processed,
- Learning the purpose of processing personal data and whether they are used appropriately for their purpose,
- To know the third parties to whom personal data are transferred domestically or abroad,
- To request correction of personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom personal data are transferred,
- To request the deletion or destruction of personal data in the event that the reasons requiring its processing disappear, despite the fact that it has been processed in accordance with the provisions of the law and other relevant laws, and to request notification of the transaction made within this scope to third parties to whom personal data has been transferred.
- Object to the occurrence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- To request the compensation of the damage in case of damage due to the processing of personal data illegally

In the application containing your explanations regarding the right you have as a Personal Data Owner and that you will to exercise your rights stated above and that you request to use; the subject you request must be clear and understandable, the subject you request is related to you or if you are applying on behalf of someone else, you must be specially authorized in this regard and you must have documentation in accordance with your authorization, it must also include identity and address information and documents that prove your identity must be attached to the application. In the event that the information regarding your requests submitted within the scope of the form is not accurate and up-to-date or an unauthorized application is made.

These requests will be evaluated and concluded within 30 (thirty) days if they are transmitted by the personal data owners using the methods mentioned above.

Although it is essential not to charge any fee for the requests, the Company reserves the right to charge a fee on the fee schedule determined by the Personal Data Protection Board.
